- · post-production waste management,
- reducing air emissions of gases and dust from the processes carried out,
- rational water management.

In the face of increasing global environmental threats, including those related to climate change, Remontowa Shipbuilding S.A. has initiated the process of identifying and considering climate-related risks and opportunities within the organizational context, planning, and operation of the Integrated Management System. We analyze both the impact of our activities on the climate and the influence of changing climatic conditions on our processes, infrastructure, and environment.

The Remontowa Shipbuilding S.A. is committed to the implementation and pursuit of action for the environment by:

- sustainable management of raw materials through their efficient use in the production process, minimising their consumption and wastage,
- rational use of energy in the production process as a result of process optimisation,
- minimisation of the amount of waste generated and proper management of the waste already generated, maximising segregation to enable subsequent recovery,
- prevention of environmental pollution and taking measures to minimise water pollution and protect local marine ecosystems,
- safeguarding the environment against possible damage and impact of the activities carried out and the effects of climate change,
- introducing technological solutions which reduce the environmental impact of the production processes carried out and climate change,
- compliance with legal requirements relating to the identified environmental aspects and compliance with all applicable environmental legislation, both locally, nationally and internationally,
